



2026-2027 TUITION AND FEES

Required Student Fees ****ALL FEES MUST BE PAID IN FULL BY AUGUST 3, 2026****

- **Application Fee** (new students): \$200.00 for first student; \$100 for each additional student. This is a non-refundable fee due when the application is submitted.
- **Enrollment Fee** (new students): \$200 per student. This fee is due upon acceptance to the school and holds the student's place for the upcoming school year.
- **Continuous Enrollment Fee (CE) Fee**: \$150.00 per student. This fee is due in January of each year and recurs each year until one of the following occurs: graduation, withdrawal or dismissal. The CE fee holds the student's place for the upcoming school year.
- **Administrative Fee**: \$500 for Kindergarten – Grade 5; \$575 for Grade 6 – Grade 12. This fee is required to facilitate campus improvements and helps to offset non-budgetary items or expenses.
- **Workbook Fee**: \$125 per student for Kindergarten – Grade 8 only.
- **Senior Matriculation Fee**: \$215 per graduate. Due before the start of the senior year; covers expenses pertaining to the senior commencement, to include a yearbook.
- **Extended Care**: For current rates for our Lower School before & after school care program, please contact the school.

Discounts

- **Multi-Student**: A discount of \$250 on fees is applied to the second student and \$300 for each additional student. This discount applies to students of the same family only.
- **Family Referral Credit**: When a family refers a new student to the school, upon acceptance, the family is given a one-time credit of \$275 towards tuition or fees.
- **Pastoral Family or Armed Forces**: A 10% discount on tuition is applied to enrolled students whose legal parent/guardian serve in a full-time pastoral role in a local church or serve on active duty or veteran status.

Scholarship Opportunities

There are several scholarship opportunities provided by Harvest Preparatory School and the Ohio Department of Education. Parents/guardians are responsible for ensuring compliance of all required documentation annually.

- **Educational Choice Scholarship (EdChoice) Program – Traditional & Expansion** (Applies to tuition only, not enrollment fees.)
- **Legacy Family Scholarship** – Parent/Guardian of student is a graduate of WHCA or HPS – 25% discount on tuition
- **Staff Student Scholarship** – Parent/Guardian is a full-time employee of HPS – 75% discount on tuition only
- **Lillian G. Watkins Legacy Scholarship** – Awarded to one rising senior annually based on mathematics and science assessment scores - \$500 one time award – can be used for tuition or fees; non-transferable.

Financial Aid

- The school offers limited financial aid to families who qualify based on financial need. The financial aid application process and additional information is available by contacting the Enrollment Services Center.

Payment Options (*Tuition Only*)

- There are two payment options available for our school. Families may choose to pay their tuition in full or families may opt for the monthly payment plan that will cover 10 months. A 10% discount is applied when the full tuition for a student is paid before the first day of school.
- The Enrollment Services Center uses FACTS Tuition Management for all tuition-related services.
